3. Old Business

- 3.1 Management Company- signed agreement and are in the process of transitioning. Each homeowner should receive a welcome letter from Sterling Management Company. Sterling will be responsible for managing budget, negotiate contracts, providing legal advice, conference room, bookkeeping.
- 3.2 Playground Play scape company is sending proposals. Current play set and swings are not in compliance with safety codes. Once contract is signed the playground be removed as soon as possible and rubber nuggets will be added to the swing to keep a portion of the park open for children.
- 3.3 ACC-we currently do not have an active committee, we consulted with management company who advised the board can act as the ACC. ACC application has been updated to remove the \$25 application fee.
- 3.4 Landscaping-contract has been reviewed. We are currently on the Winter schedule which provides, grass cutting twice a month and once a month park cleaning. In the Summer those services double.

4. New Business

- 4.1 Replacement Lights at both entrances, testing solar lights.
- 4.2 City of Houston Stress Test/Drainage Analysis, Laurel Springs RV park drainage plans have been reviewed, city has confirmed the RV park is in compliances and retention pond at the bottom of the hill can retain more water. If flooding does occur in our community it would be the responsibility of the community. Joe suggestion community call Region Twelve at 713-767-3500 to report complaints.
- 4.3 Removal of fence obstructing pond walkway- homeowner is outside of Lakewood Cove, Board plans to send letter to have homeowner remove it, if they don't comply HOA will remove.
- 4.4 HOA is looking for a platform for the community to submit suggestions and vote on ideas versus messaging the board directly or utilizing Facebook page.
- 4.5 Yard Signs yard signs are being purchased to provide more visibility of HOA Meetings, Events at the park, Garage Sales, etc.
